- It is understood Brett Turner Photography is the exclusive official photographer retained to perform the photographic services requested on this contract.
- Brett Turner Photography may substitute another photographer to take the photographs in the event of Brett Turner's illness or scheduling conflicts. In the event of such substitution, Brett Turner Photography warrants that the photographer taking the photographs shall be a competent professional.
- No part of any order, including proofs, will be delivered until the balance is paid in full.
- Brett Turner Photography reserves the right to use the negatives, files, and/or reproductions for advertising, display, publication, or other purposes. Negatives, files, and previews remain the exclusive property of Brett Turner Photography/Brett Turner.
- Upon signature and receipt of deposit (1/2 of package price), Brett Turner Photography shall reserve the time and date agreed upon and will not make any other reservations for that time and date. For this reason, unless the studio is able to fully replace the cancelled reservation, all deposits/reservation fees are non-refundable, even if the date of the wedding is changed or the wedding is cancelled for any reason.
- One half of package price is due upon reservation, and the balance of the package price is due at least 14 days before the event.
- If Brett Turner Photography/Brett Turner cannot perform this contract due to fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to the photographer's illness or emergency, then the photographer shall return the deposit/fees paid to the client but shall have no further liability with respect to the contract. This limitation on liability shall also apply in the event that photographic materials are damaged through processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the photographer. In the event Brett Turner Photography/Brett Turner fails to perform for any other reason, Brett Turner Photography/ Brett Turner shall not be liable for any amount in excess of the amount of payment made by client.
- Client is aware that color dyes in photography may fade or discolor over time due to the inherent qualities of dyes and client releases Brett Turner Photography from any liability from any claims whatsoever based upon aging, fading, or discoloration due to such inherent qualities.
- The charges in this contract are based on Brett Turner Photography's standard price list or negotiations pertaining to this specific event. This price list is adjusted periodically, and future orders shall be charged at the prices in effect at the time that the order is placed.
- Brett Turner Photography will in good faith make reasonable effort to accommodate requests for specific photos; however, due to the unpredictable nature of the wedding day, Brett Turner Photography will not be held liable for any unmet photo requests.
- NOTICE OF COPYRIGHT: It is ILLEGAL to copy or reproduce these photos elsewhere without Brett Turner Photography/Brett Turner's express written permission and violators of this Federal Law will be subject to its civil and criminal penalties.
- This contract incorporates the entire understanding of the parties. Any modification of this contract must be in writing and signed by both parties.
